4. Proposed ATV Routes

Ashley Schwarzenstein was present to request 3 segments of road in the City be open for ATV use. They are Bennett Rd from E Leffler to CTH YZ, Brue Rd from Lehner Rd to City limits, Brennan Rd from STH 23 to City Limits. These are roads that run along the City/Town border with joint jurisdiction. Opening them will simplify routes and avoid extra signage. The Mayor asked about proper signage and advised the club should try to provide additional signs if they want the route going in soon as the City would have to order extra signs. Public Works Director Lee didn't see a problem with the routes.

2. Outdoor Seating Requests from Class B License Holders

Bob Page from Bob's Bitchin' BBQ would like to provide outdoor seating to his customers during the summer. This would involve placing seating on the sidewalk of E Merrimac St and utilizing 3 parking stalls for fencing. Bob would also be required to have an expanded liquor license to include this area in his premises.

Mayor Novak presented example draft ordinances from Mineral Point for outdoor seating. Proof of insurance would have to be included with the application along with the expanded liquor license. A new ordinance would apply to all of Dodgeville, not just this request. Owners would have to provide the fencing. The new ordinance would come back at the next council meeting.

1. Town Square

The Chamber will be resubmitting their street use and Class B liquor license applications for a revised Town Square on East Merrimac St. The new tentative dates are July 9 - 26, but could change . This item will come for approval at the next Council meeting. Per the City attorney the street cannot be closed for three months due to public domain laws.

The date of Saturday, July 24th could be a potential problem date and the time frame for the Town Square could be moved to July 2-19 instead. The dates will be firmed up by the next council with an updated list of events. An ordinance will have to be changed and the permits updated with corrected dates for final approval.
