1. 2020 Annual Library Report - Library Director Vickie Stangel

Library Director Vickie Stangle provided the 2020 annual report for the library. Highlights included: increased use of digital books and virtual programs, heavy use of library Wi-Fi, and the Annex Expansion. Staffing was down for 2020 from 6.4 to 5.7 FT staff members. The County payment is likely to drop and is possible that American Rescue Funds could be distributed to libraries from the State.

1. Dodgeville Area Chamber of Commerce-Street Use Permit-Town Square-May 28 through September 7

Chamber Director Beth Mikrut-Gilles was present to discuss the town square idea for the summer as proposed on E Merrimac St. Mikrut-Gilles provided examples of how the 2020 week long town square was highly successful. Outdoor seating is now a priority for many. Some concern from property owners on the impacted block was expressed. Many council members also expressed concern on the 3-month length of the proposed town square and wondered if a shorter time frame and if the opposite block of Merrimac could be a better fit. Mikrut-Gilles suggested a possible new time frame incorporating Farmer's Appreciation week which is July 9-19th.

2. Upgrade timekeeping program to miTime

Aulik explained that Payroll would like to move off of the existing ADP system and switch to miTime. The new system would integrate with existing programs and eliminate the need to double enter time. Employees can enter time via an app on their phone or tablet. The up front cost is \$6,400 with annual maintenance of \$1,100 which is cheaper than ADP's average cost of \$2,680.
