8. HVAC Ionization Proposal

Johnson Controls presented a proposal which includes adding Auto-Cleaning Needlepoint Bipolar Ionization System to 11 furnace system units throughout the City of Dodgeville buildings to assist in protecting our staff & residents that enter our buildings. This ionization unit works by flooding the air with millions of either negatively or positively charged particles to react with both microbes and VOC contaminants. This system causes production of clusters of hydroxyl radicals which are formed on the surfaces of microbes, removing hydrogen from the microbial cell walls, thereby killing them and knocking them down so they can be wiped up. The ionization has been shown to cause smaller particles to coalesce into larger particles because of the opposite charges which enhances the effectiveness of static filters. Cost is \$26,950 for all 11 units and we have \$76,000 which can be applied to COVID19 expenses plus FEMA funds. Mayor Novak thinks this will qualify for reimbursement as a COVID19 expense. DeVoss made a motion to approve Johnson Controls contract in the amount of \$26,950 seconded by Tremelling contingent on COVID19 reimbursement, if not eligible for COVID reimbursement, funds will come out of Police Departments carryover fund. 9. Hazzard Pay-COVID 19

Under the emergency order that we passed in March we increased the hazard pay for ambulance 3 times the amount for on call. The reason we did that at the time was that we were concerned about staffing. Some of our EMT's were working in places that were concerned about the EMT's being exposed and we were very concerned that we would not have any EMT's to work. Attorney, Eileen Brownlee is recommending that we stop the hazard pay for now for the ambulance due to it being very costly and a reduction in cases. Hazard pay is working but is eating up the EMS budget. DeVoss made a motion to stop COVID19 Hazard pay for the Ambulance Department effective at the end of the current pay period.
