### 3. Census 2020 Participation

Clerk Lisa Riley provided the current Census 2020 participation rate for the City of Dodgeville at 72.2% in comparison to the Statewide rate of 64.6%. She encouraged people to respond to the Census, as funding for various entities rely on the Census numbers. The Census has been challenging since they have suspended any door-to-door contact with people, along with libraries being closed for those that do not have access to the internet/computers.

4. COVID-19 Update

Clerk Lisa Riley stated that City Hall is still closed to the public. Inquiries regarding park shelter reservations, Ley Memorial Pavilion reservations, and recreation programs are coming in frequently along with request for refunds. EMS Chief Brian Cushman updated the Council that their call volume is up, supply chain of PPE is getting dried up with orders 3-4 months out, and he is working on grants for COVID-19 expenses. Police Chief David Bauer also stated supplies are hard to get and is trying to keep up with the constant changes with guidelines, ATT/First Net cellphone changeover is happening on Thursday, the front cement work at the Police Department was completed, and they are currently working on a business listing which they learned was important during the pandemic. Fire Chief Brian Whitehouse provided COVID-19 updates stating the respirators came in and they are trying to minimize traffic at the building. Library Director Vickie Stangel stated they are starting up the Book It & Bag It program again with pick up outside, new patrons are coming into the system, and the Summer Program has changed to an online program. Mayor Novak provided an update on the current status of COVID-19 happenings. He stated he talks with Beth, from the Chamber, 1-2 times/week, getting updates. Currently, DodgeFest is on hold. Farmers Appreciation is probably going to be cancelled and Pop-Up Town Square will potentially be held. Mayor Novak also updated the Council that the Einerson house is down and Rule Construction is waiting on dumpster containers, as there is a shortage with the current pandemic. The Amish farmer removed the one trailer on East Chapel Street and the City will need to pay demolition costs for the other trailer. Dave Rule is working on his schedule for removing the remaining 2 houses behind Jeffery's. There are still tenants on North Main Street, and due to the pandemic, no one can be evicted at this time to move forward.

# 15. ACT 185-Waiving Interest and Penalties of Property Tax Payment Installments

The following email was received from Iowa County Treasurer Connie Johnson regarding ACT-185-Waiving Interest and Penalties of Property Tax Payment Installments:

On April 15, 2020, Governor Evers signed into law ACT 185-Waiving Interest and Penalties of Property Tax Payment installments due on or after April 1, 2020, for the 2019 tax season. The ACT allows Counties and Municipalities to pass Resolutions allowing the interest and penalty waived from the installment due date of July 31 until October 1. This would only apply to taxpayers that have paid their first installment by January 31 to earn the second installment option. All delinquent parcels will continue to accrue interest and penalty from February 1.

What does this mean for Municipalities and School Districts?

If the County signs the Resolution

- Each Municipality will have the <u>option</u> to participate by also passing a Resolution.
- If both the Municipality and the County sign the resolution this would give taxpayers two more months to pay their second half installment without being charged interest and penalty.
- Iowa County could have 1-29 Municipalities participating. Creating different due dates, some will still have the July 31, and others would have October 1.
- This will create two settlements regardless if the Municipality decided to sign a Resolution. The first settlement will be August 20 for what was collected thru July 31, and September 20 settling in full, less specials not collected, with each taxing jurisdiction (Municipality, Schools and Tech Schools). This moves the existing full August 20 settlement to September 20.

If the County does not sign the Resolution

• All second installments 2019 tax payments will be due by July 31 and the County would settle in full on August 20 with all taxing jurisdictions.

I will be discussing this resolution with our General Government Committee on May 7<sup>th</sup> and would like to get your feedback if your municipality would be considering passing a

resolution and if passed what impact this would have on both Municipalities and School Districts.

Please email me any questions or concerns.
