 - 1. Spring Election April 7, 2020

Clerk Lisa Riley updated the Council on the Spring Election. She thanked the poll workers that stepped forward to work, staff members that provided assistance in many aspects from setting up to working at the polls, and to the three National Guard members who also worked the polls. Riley shared her thank you's that were posted on Facebook to poll workers, fellow colleagues, and area businesses that helped by providing food options that were individually wrapped, as required by the WEC. The Dodgeville Police Department provided two officers for each shift, which helped people feel more comfortable. City hall staff filled in wherever needed. Clerk Lisa Riley also thanked David Bauer and Brian Cushman for providing the supplies needed for safety.

"A special thank you to all of the poll workers who graciously agreed to work at the polls and helped make the day run so smoothly during a time of

election changes and in the middle of a pandemic! I am so grateful to Kathy Buss and Janice and Jeffery Grayson for getting the required Chief Election

Inspector training hours in at the last minute when I lost all my regular certified workers. To my regular crew, we missed you today but know your health and safety is of the utmost importance! I am so lucky to have the best co-workers who stepped up to the plate when I was desperate to fill positions and prepare a safe environment! Thank you Julie, Lisa, Cathy, Jeremy, Greg, Vickie, Carol, EMS Chief Brian, Dodgeville PD-Chief Bauer, Lieutenant Wilhelm, Officers Pepper, Durni, Groom, Birdsill (hope I didn't miss anyone)! Special thanks to our Street Department staff who built the plexiglass barriers to help keep everyone safe. Thank you to my trained poll workers Kathy Buss, Janice Grayson, Jeff Grayson, Lorna Bunker Kieffer, Diane Messer, Bob Scheidegger, Marie Oelklaus, Mary Jacobson, and Faye Glonek for being willing to be there to assist in making the election go on without a hitch! And lastly, to the three National Guard members Chad Schult, Uriah Ottoway, and Bailey Lawinger for answering the call to service. "I'd like to send a special shout out to some area businesses for being very accommodating in our Election Day preparations! Riley also stated that no results were tallied at the end of the night, as required by federal order. Counting will happen on Monday, April 13th as results cannot be released until after 4:00 p.m. with Jeff and Janice Grayson and Kathy Buss. The City still has approximately 120 outstanding ballots, with about 10 people coming to vote in person as they stated they did not receive their ballot.

Mayor Novak commented that he had talked with several people and stated there were lots of compliments on how our polling place was run. Novak complimented Clerk Lisa Riley for her efforts during the election due to the overwhelming numbers of absentee ballots.

2. COVID-19 Updates

Mayor Novak updated the Council on the current setup at City Hall. The office is still closed to the public and each employee is set up in separate offices. Randy is working from home. Randy checks in with Greg every day. He continues to do inspections, etc.

Every couple days/once a week, Lands' End CEO Jerome checks in with Todd to provide updates and is trying to stay on top of any changes. They have extended furloughs to May 1st. Jerome's intention is that everyone will be coming back - they are furloughed, not laid off.

The library is closed to the public. Dave Bauer gave an update on the police department during this time regarding calls, officers, and equipments. They have seen an increase in mental health calls. Brian Cushman provided an update on equipment and the staff reduction requirements for Ambulance #2 and #3, as per Order #21. They have had a few members that have needed to sit out for 24-36 hours, due to exposure. They are getting more information from dispatch so they are aware what PPE needs to be in place for the call. It takes a rig out of service for about 1 1/2 hours to decontaminate after a call. He has been working on recruiting some members for the on-call shifts - recently went to Cobb.

Clerk Lisa Riley thanked both David Bauer and Brian Cushman for coming down to City Hall and fogging the area following the election.
