1. Walmart #847-Request for Expansion of Premises Description on Alcohol Beverage License

Tuesday, August 6, 2019

5:30 PM

Michael Lenz, Assistant Manager at Walmart was present to address the Council regarding the store's request to expand the premise description on the alcohol beverage license to accommodate online grocery pickup services. They are planning on starting the grocery pickup service October 29th. A customer will not be able to purchase cigarettes or firearms through the online service pickup. He explained that the customer will order and pay online, park in a specified stall, and the groceries will be delivered to their vehicle. Regarding alcohol sales, the person ordering the merchandise must be the individual picking up the order and will need to provide photo identification. Walmart has a specified policy for how they handle these types of transactions, which was provided to the Council for review. Ald. Borne questioned the logistics of the identification for alcohol pickup and the threat of underage customers being served.
