1. 2018 LWMMI Insurance Dividend

Clerk Lisa Riley informed the Council that the City received their 2018 insurance dividend check, in the amount of \$19,501.00. This equates to 31% of the 2018 Work Comp Premium. Including the 2018 dividend, over the past 13 years, LWMMI has returned \$100,871 to the City. The 2018 dividend amount of \$3,300,000 will be shared by 430 policyholders. Since 2006, LWMMI has paid back dividends in excess of \$22,000,000.
