## ORDINANCE NO. <u>2018 - 1375</u>

## AN ORDINANCE TO CREATE SECTIONS 7.07(3)(00) AND 7.07(5)(b)2. AND 3. AND TO AMEND SECTION 7.07(9)(a) OF THE MUNICIPAL CODE OF THE CITY OF DODGEVILLE, IOWA COUNTY, WISCONSIN, RELATED TO PARKING ON EAST NORTH STREET, EAST DIVISION STREET AND ON THE EAST SIDE OF CITY HALL

THE COMMON COUNCIL OF THE CITY OF DODGEVILLE, IOWA COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

**Section I:** Section 7.07(3)(00) of the municipal code of the City of Dodgeville shall be and hereby is created to read as follows:

*"(3) PARKING PROHIBITED AT ALL TIMES* 

(00) On the north side of East Division Street, east of the intersection with Iowa Street to the east City limit."

**Section II:** Section 7.07(5)(b)2. and 3. of the municipal code of the City of Dodgeville shall be and hereby are created to read as follows:

*"(5) WINTER PARKING REGULATIONS* 

*2. Street to Bennett Road.* 

On the south side of East North Street, from Johns

*3. On the north side of East Division Street, east of the intersection with Iowa Street to the east City limit."* 

**Section III:** Section 7.07(9)(a) of the municipal code of the City of Dodgeville shall be and hereby is amended to read as follows:

*"(9) PARKING LIMITED TO CERTAIN VEHICLES.* 

(a) Fourteen parking spaces are hereby reserved from 7:00 A.M. to 5:00 P.M. Monday through Friday on the east side of City Hall for City officials only. Such reserved parking shall be appropriately indicated by the erection of signs."

<u>Section IV:</u> This ordinance shall take effect upon its passage and publication as required by law.
