Mayor Novak read the following letter received from Council President/Alderperson Mark James:

To: Todd Novak, Honorable Mayor, City of Dodgeville, WI Common Council Members, City of Dodgeville, WI As my final action(s), if allowed, prior to submitting my resignation from the Dodgeville, WI City Council, I submit my resignation as Council President and I nominate Dan Meuer to be Council President.

That being said, I hereby formally submit my resignation from the Dodgeville, WI City Council to the Honorable Todd Novak, Mayor of Dodgeville, WI effective this day, the 11th day of October, 2018.

Mayor Novak commented that Mark James had expressed that he didn't feel that it was fair to the Council or the public that he was missing so many meetings with all of his traveling, since his semi-retirement. Novak stated that James has served full-time since 1995 and had been appointed to fulfill an open seat vacated by Trisha Schroeder prior to 1995. Mayor Novak thanked Mark James for his service and commitment to the City and commented Mark will be missed, appreciating especially his institutional knowledge. Novak asked that the Clerk look into having a plaque made with his Council table name plate which will be presented at a later Council meeting date to recognize his service.

Since Administration and Personnel Committee is currently meeting for police negotiations and other budget needs, Mayor Novak appointed Ald. Forseth to replace Mark James on this committee. The remaining Standing Committee appointments will be put on the next Council agenda.

3. Appoint Successor for Office of Alderperson-District 2

Mark James' position is up for election in April of 2019.

With the Alderperson vacancy in Wards 3 & 4-District 2 (southwest corner of the City), the Council will solicit interest from interested residents. Kasi Greenwood, of the Dodgeville Chronicle, will address the need in the City Council coverage story. All inquiries should be directed to Clerk Lisa Riley. The Council hopes to appoint a replacement at a November meeting.

Public Works Director Greg Lee addressed the Council regarding the need to replace the current bucket truck. In a recent inspection, the truck failed inspection and can no longer be used. Greg has been searching for a smaller used truck, potentially 450-550 chassis. A new bucket truck costs approximately \$120,000. Greg is pursuing a used truck in the \$30,000-\$60,000 range on online surplus sites or Alliant Energy fleet auction. Unfortunately, a decision to purchase has to be immediate in order to make the
