3. Dodgeville Truck Stop Property

Mayor Novak read the following report regarding the Dodgeville Truck Stop property:

Tuesday, August 7, 2018

The Dodgeville Truck Stop has been in foreclosure since December 2016. The current mortgage holder is NCP Chicago Holdings LLC. The foreclosure has been a lengthy process because there were 19 liens on the property totaling almost \$700,000. Of that amount \$490,860.84 was the mortgage and interest.

For the past two years the city has been monitoring the court process on the property as the condition of the property has been not only a concern to the city but the residents. There was an individual from Dubuque who had expressed interest in the property, but no progress was made.

A few months ago, the city council decided that the best way to deal with the property was for the city to try to purchase it. They authorized Mayor Novak to negotiate a deal to try to purchase the 6.1-acre property.

On June 12 NCP Chicago Holding LLC accepted an offer to purchase from the city for the property. The agreement is the city will pay \$100,000 for the property and the back taxes of \$100,258.46 to Iowa County for a total of \$200,258.46. The back taxes go back to 2013. For tax purposes the property has a fair market value of \$239,800 in its current condition. The city will not be using taxpayer dollars to purchase the property, but will be using excess funds returned to the city when the Lands' End TIF District was closed last year. Some of the of those funds were designated for economic development.

Once we had an agreement in place, NCP filed papers with the Iowa County Circuit Court to finish the foreclosure sale, which Judge Koehler approved on July 26. The original closing date was set for July 31 but changed to August 8. The process of getting a clear title is taking longer than thought. At this point, we still expect to close on the property soon, but not sure of an exact date.

Once the city has title of the property Rule Construction will do a demolition on the property for a cost of \$14,500. The city will then market the property for sale. Currently we have been approached by two site finders, who represent companies, that are interested in the property.

The city will determine a price on the property, which will be based on a developer's agreement with whoever purchases it.

The Council reviewed the bid, showing an additional cost for removing the concrete. Motion by Ald. James to accept Rule Construction's demolition bid for \$14,500 and leave the concrete in place. Second by Ald. Forseth. Motion passed unanimously.

AN ORDINANCE ANNEXING TERRITORY TO THE CITY OF DODGEVILLE, IOWA COUNTY, WISCONSIN

THE COMMON COUNCIL OF THE CITY OF DODGEVILLE, IOWA COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

<u>SECTION I.</u> TERRITORY ANNEXED

Tuesday, August 7, 2018

5:30 PM

In accordance with Section 66.0217, Wisconsin Statutes, and the petition for direct unanimous annexation made pursuant to Wis. Stat. sec. 66.0217(2), filed with the Clerk of the City of Dodgeville, Iowa County, Wisconsin, signed by all the owners of real property within such territory and all jurisdictional and procedural requirements having been met, the following described territory in the Town of Dodgeville, Iowa County, Wisconsin, is hereby annexed to the City of Dodgeville, Iowa County, Wisconsin, to-wit:

Part of the Southwest Quarter (S.W.1/4) of the Southwest Quarter (S.W.1/4) of Section Twenty-two (22), Township Six (6) North, Range Three (3) East, Iowa County, Wisconsin, described as follows:

Lot 1 of Certified Survey Map #1664 recorded in the office of the Register of Deeds for Iowa County, Wisconsin, on March 27, 2018, at 4:00 p.m., in Volume 12 of Certified Survey Maps at page 45 as Document No. 355938.

Parcel contains 3.19 acres, more or less.

<u>SECTION II.</u> EFFECT OF ANNEXATION

From and after the date of this ordinance the territory described in SECTION I shall be part of the City of Dodgeville, Iowa County, Wisconsin, for any and all purposes provided by law and all persons coming or residing within that territory shall be subject to all ordinances, rules and regulations governing the City of Dodgeville, Iowa County, Wisconsin.

SECTION III. DISTRICTING

The territory is hereby annexed to the Ninth (9) Ward.

<u>SECTION IV.</u> TAX PAYMENTS TO TOWN

The City shall pay to the Town of Dodgeville annually, for 5 years, an amount equal to the amount of property taxes levied on the annexed territory by the Town of Dodgeville, as shown on the tax roll under Wis. Stat. sec. 70.65, in 2017.

SECTION V. OTHER

There are no persons residing in the territory annexed. The purpose of the annexation is to provide utility service to the property at City cost.

<u>SECTION VI.</u> SEVERABILITY

If any part of this ordinance is invalid or unconstitutional, or if the application of this ordinance to any person or circumstance is valid or unconstitutional, such invalidity or unconstitutionality shall not affect the other provisions or applications of this ordinance which can be given effect without the invalid or unconstitutional provision or application.

<u>SECTION VII.</u> EFFECTIVE DATE

This ordinance shall become effective upon its passage and publication or posting as required by law.
