#### B. Finance Committee

1. Police Dept Request to Use Carryover Funds for Firearms Purchase

Police Chief David Bauer and Lieutenant Brandon Wilhelm addressed the Council regarding the need for purchasing new firearms for the Dodgeville Police Department, following meeting with the Finance Committee. They are requesting to use department carryover funds for the purchase. The Police Department has had the 1911 Smith and Wesson firearms for the past ten years and no longer have an armorer on staff to service the weapons. They attempted to send their firearms instructor to a recent armorer school, but the class was cancelled due to a lack of Police Departments carrying this type of weapon for duty. They are looking to replace their existing weapons with Springfield XD Mod2 firearms. They anticipate the cost to be approximately \$8,247.49, which will be offset by the sales of the 1911 firearms (to current officers at approximately \$450 a piece - totaling \$4,950). The out of pocket costs would be *approximately* \$3,297.49. Motion by Ald. Forseth to approve the Police Department's request to use carryover funds for the purchase of firearms, as recommended by the Finance Committee. Second by Ald. Borne. Roll Call: Ald.   - 1. Cell Tower Request-Bug Tussell Wireless-Samantha Mueller

Samantha Mueller, Site Development Specialist for Bug Tussel Wireless, addressed the Council looking for City owned property to be leased to construct a wireless communication facility for providing wireless internet to the area. They are looking to lease an area approximately 100' X 100'. Samantha presented a proposal for an initial lease term of 5 years, at \$3,000 per year. She stated that time is of the essence as Bug Tussel has a very aggressive timeline to complete this project. Samantha had met with Randy Edge and he proposed potential areas of City owned property (behind Walnut Hollow, area below Farm & Fleet-County YZ/Bennett Road property, and Harris Park). They have different options of towers, depending upon the available space to erect the tower. There are 27 approvals when erecting a tower - FCC, Fish & Wildlife, multiple Native American Tribes conducting archaeological digs (they pay approximately \$7,000 - \$10,000 per tribe), etc. Guide towers cost approximately \$250,000 to build. Monopoles cost about \$400,000-\$500,000 paid out of pocket by Bug Tussel. They were just awarded 3 grants for Green and Lafayette Counties. They will be applying for more grants. Mayor Novak stated he would not be in favor of erecting a tower at Harris Park and Council members agreed. Mayor Novak commented that he thought the rent amount proposed was very low for tying up property for 27 years. Samantha stated that lease amounts could increase for co-location with another company i.e. AT&T and FirstNet. This would provide additional providers with options for City residents. Samantha stated that the range covers out to 5 miles from the center of the tower for internet service. They are looking to put up new towers every 5 miles. She stated that the Council could view the Barreltown Road tower between Dodgeville and Mineral Point.

The Council wanted to review the request in more detail. Mayor Novak sent the request to Administration and Personnel for further review and report back to Council. Mayor Novak asked Samantha if she would come back and meet with the Committee and she responded that she would be happy to do that. Samantha also stated they are anxious to move on this project and they are trying to become familiar in the area by working with the Chamber to be the number one sponsor of the Dodgefest Music Fest. Mayor Novak asked Clerk Lisa Riley to connect with Samantha when a meeting is set up.
