4. AN ORDINANCE TO AMEND SECTION 12.02(11)(b) OF THE MUNICIPAL CODE OF THE CITY OF DODGEVILLE, IOWA COUNTY, WISCONSIN, RELATING TO CLOSING HOURS FOR RETAIL CLASS "A" FERMENTED MALT BEVERAGE AND "CLASS A" INTOXICATING LIQUOR LICENSED PREMISES

ORDINANCE NO. <u>2018 - 1366</u>

AN ORDINANCE TO AMEND SECTION 12.02(11)(b) OF THE MUNICIPAL CODE OF THE CITY OF DODGEVILLE, IOWA COUNTY, WISCONSIN, RELATING TO CLOSING HOURS FOR RETAIL CLASS "A" FERMENTED MALT BEVERAGE AND "CLASS A" INTOXICATING LIQUOR LICENSED PREMISES

THE COMMON COUNCIL OF THE CITY OF DODGEVILLE, IOWA COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

Section I: Section 12.02(11)(b) of the municipal code of the City of Dodgeville shall be and hereby is amended to read as follows:

"(11) CLOSING HOURS. No premises for which an alcohol beverage license has been issued shall remain open for the sale of alcohol beverages, as follows:

(b) <u>Retail Class "A" Fermented Malt Beverage License and Retail "Class A"</u> <u>Intoxicating Liquor License.</u> . For premises for which a Class "A" license has been issued, no fermented malt beverages may be sold between the hours of 12:00 midnight and 6:00 a.m. For premises for which a "Class A" license has been issued, no intoxicating liquor may be sold between the hours of 9:00 p.m. and 6:00 a.m."

<u>Section II:</u> This ordinance shall take effect upon its passage and publication as required by law.
