ORDINANCE 2018 - 1365

AN ORDINANCE TO AMEND THE ZONING ORDINANCE AND MAP OF THE CITY OF DODGEVILLE, IOWA COUNTY, WISCONSIN

WHEREAS, the Common Council of the City of Dodgeville, Iowa County, Wisconsin, has determined to consider a proposed amendment to the Zoning Code and map of the City; and

WHEREAS, the Plan Commission of the City of Dodgeville met for the purpose of making a recommendation to the Common Council relating to said proposed amendment and has recommended to the Council that such amendment be adopted; and

WHEREAS, said proposed amendment is consistent with the City's Comprehensive Plan; and

WHEREAS, notice of a public hearing on said proposed amendment was published in the **Dodgeville Chronicle** on December 21 and December 28, 2017, and sent to adjoining landowners at least 10 days prior to public hearing; and

WHEREAS, a public hearing was held on January 10, 2018, with respect to said proposed amendment;

NOW, THEREFORE, THE COMMON COUNCIL OF THE CITY OF DODGEVILLE, IOWA COUNTY, WISCONSIN, DO ORDAIN AS FOLLOWS:

Section I: The Zoning Code and map of the City of Dodgeville are hereby amended to reclassify for zoning purposes the following described parcel of land from its current B-C Central Business Zoning District classification to the PUD Planned Unit Development Zoning District classification:

Lot 1, Assessor Plat #2, City of Dodgeville, Iowa County, WI

Section II: This ordinance shall take effect upon its passage and publication as required by law.

WHEREAS, Wisconsin Statute section 66.1003(4)(a) permits a Common Council to vacate any street or portion of a street in the City when the public interest requires it:

WHEREAS, a platted portion of West Fountain Street lying between Main and Level Streets is currently occupied by adjoining property owners;

WHEREAS, it appears to be in the best interest of the public and the City that the portion of West Fountain Street more particularly described below be vacated:

WHEREAS, a notice of the proposed discontinuance and vacation of a portion of West Fountain Street and public hearing thereon was published on December 21, 28, 2017, and a copy of said notice was delivered or mailed to the owners of all the frontage of the lands abutting on the street proposed to be vacated and to the Secretary of the Wisconsin Department of Transportation;

WHEREAS, a public hearing was held on January 10, 2018, pertaining to the proposed discontinuance and vacation of the portion of West Fountain Street more particularly described below;

WHEREAS, this Council finds that all of the procedural requirements provided by law have been complied with and fully met;
