4. Reports/Recommendations

A. Mayor/Council President & Clerk

Council President Mark James informed the Council that the Mayor would not be at tonight's meeting, as he is in Session in Madison. President James asked all the Council members to take a drive around their respective wards to notate areas that may need attention to clean up of properties.

Clerk Lisa Riley informed the Council that the Spring Newsletter was mailed. Ald. Weber stated he heard many positive comments on the newsletter.

The old street signs have been taken down and delivered to Time and Again Vintage, to be sold.

Riley reminded the Council that Committee appointments will be done at the next Council meeting and if they are requesting any changes, to get in touch with Mayor Novak.

1. Unofficial Spring Election Results

Clerk Lisa Riley provided the Unofficial Election Results from the April 4, 2017 Spring Election.

Riley congratulated the following incumbents on their re-election to the Council: Shaun Sersch, Mark James, Dan Meuer, and Michael Borne. Certificates of Election will be supplied to the candidates after canvassing. Oaths of Office will need to be done prior to the next Council meeting.

B. Assessor

1. Assessor Plat

Assessor Randy Edge presented a request for proposal of an Assessor's Plat from Cliff Olson, due to affected parties not being able to agree on property lines. There are three properties with overlap. He stated a Certified Survey Map can resolve the issue if the parties agree. A letter was received from Charles Kreimendahl objecting to the meeting going ahead on grounds of inadequate notice. Edge stated that if an Assessor's Plat would happen, it would include both Mr. Kreimendahl's and Don Marten's properties.

Engineer Larry Schmit proposed going ahead with the Certified Survey Map (CSM) option, as the City did not have interest in the past to do an Assessor's Plat. He stated not long ago everyone was agreeable with the lines of the proposed CSM. He informed the Council that a great deal of additional costs would be incurred if an Assessor's Plat were required. Schmit recommended as far as he was concerned that the City should do nothing at this time. Both Tim and Mary McKinley agreed to the lines as presented on the CSM, which would get the McKinleys' house outside of the street, by vacating 12' of the street to accommodate the front porch of the home and providing the appropriate land to Mr. Olson. Don Marten agrees with the proposed CSM and is not in favor of a proposed Assessor's Plat. Schmit commented that the zoning requirements are difficult in that area and Mr. Olson needed to request a variance for building his garage previously. Currently, the McKinleys' home is in the public right of way which will need to be corrected for a request to vacate part of Fountain Street. This request will need to go to Plan Commission.

Existing budget monies and approved carryover monies will be used to purchase the vehicle. The new 2017 Sport Utility Vehicle will replace the 2012 Ford Taurus. Chief Bauer asked for permission to sell the 2012 vehicle at auction, using sale proceeds to help off-set costs for interior equipment, exterior markings and facilitate the transfer of equipment for the new police vehicle purchased. Motion by Ald. Tremelling to accept and award the bid from Hallada Motors (Ford) Inc. for the purchase of a marked 2017 Policy Utility Interceptor AWD for \$30,227. Second by Ald. Forseth.
