1. Introduce Officer Blake Weier/Lieutenant Brandon Wilhelm/Sergeant Todd Oellerich

Police Chief Bauer introduced his new full-time Police Officer, Blake Weier, who is replacing one of the positions vacated thru a promotion. Officer Weier started his full-time position on February 16, 2017. Officer Weier expressed appreciation for being hired by the City and is looking forward to his new position.

Police Chief Bauer re-introduced his new full-time Lieutenant, Brandon Wilhelm, who is replacing the position vacated by Lieutenant David Pope. Lieutenant Wilhelm started working for the Department in 2006 and started his new position as Lieutenant on March 8, 2017.

Police Chief Bauer re-introduced his new full-time Sergeant, Todd Oellerich, who is replacing the position vacated by Sergeant Rose Shriver. Sergeant Oellerich started working for the Department in 2007 and started his new position on March 14, 2017.

Chief Bauer is looking forward to new ideas and new energy. Bauer is excited about what the future will hold for the Department. There is one more officer position that they are hoping to have filled by June 2017.

2. Update/Request regarding Police Dept Garage Cement Work

3. Update/Request Regarding Police Dept Body Camera Grant

Chief Bauer discussed Federal Body Camera Grant that the department had received. It was a 50/50 grant with a lot of requirements that we were not fully aware of when we applied for the grant. One requirement being that we would need to send someone down to New Orleans to attend a conference with an estimated cost of \$2,900. Chief Bauer feels he can't send someone to New Orleans. With the grant we could make it work out financially but personally does not feel that we will get anything out of it and with his current staffing issues does not feel he can let someone go. Bauer sees it as all cost an no benefit. Bauer called the federal agency to see if we can't send someone to New Orleans if that would make us ineligible for the grant. Waiting to hear back.

Mayor Todd Novak just informed Chief Bauer that the City of Dodgeville received a \$4,000 equipment grant from the Department of Transportation that could be used towards the body camera purchase. Dodgeville Lions Club has also pledge monies for this project as well. With these two financial avenues would should be pretty close to where we need to be financially but may need a little more than the \$13,000 matching funds originally agreed upon. Not throwing the grant out yet.

D. Public Works Department

1. Authorization to Solicit Bids for Public Works Trucks

Greg reported that the Sewer Truck transmission went out and the repair is \$4,500 plus other repairs which is essentially over the value of the truck. In the past the Council had also discussed a new water truck and Greg would like to lump the two truck purchase together hoping for a better deal. Today Greg took Todd out to look at a Street Department truck that has been declared a safety hazard. Water & Sewer Trucks are 2005 models with roughly 60,000 miles on them and the Street Truck is a 1994 model.

Request is to solicit bids for 3 new trucks. One truck or van for the Water Department, one truck for the Street Department, and one truck for Public Works Director. Sewer Department will purchase the current Public Works Director's Truck as Greg does not feel he would like to put a financial burden on the Sewer Department at this time with the purchase of a new truck with its current upgrade costs to the sewer plant as the other sewer truck is not in that great of shape and may need to be replaced in the sometime distant future. Mayor & Greg recommend that all trucks be placed on a rotation schedule for future budgeting purposes. Greg is hoping for a better deal with purchasing multiple vehicles. We will try to re-coop some monies by selling the old vehicles on a Government Surplus Sale.

4. Approve Authorized LPA Government Appointee for Highway 191 Project

In preparation of the STH 191, East Division Street Project the City of Dodgeville needs to appoint responsibility to two City of Dodgeville employees to approve the offering price by signing off on them as well as revision that may be made. The WI Department of Transportation review appraisers will approve the Project Data Book and conduct the appraisal reviews. They shall indicate approval of the appraised amount of compensation to be offered to the property owner using Offering Price Report & Submittal. Subsequently, the offering price shall be approved by City of Dodgeville employee and signed by City of Dodgeville Employee. The Administrative Revision is to be reviewed by, approved and signed by the Wisconsin Department of Transportation. Then, employee will approve and Mayor will sign it.

Meuer made a motion to require City Assessor, Randy Edge to sign off on the approval of the offering price on all transactions plus any revisions that may be made and than Mayor Todd Novak will be signing off on them with City Clerk, Lisa Riley as back up for the Mayor.
