Mayor Novak reported that notification was received from Department of Natural Resources approving both a reduction of the PECFA reimbursement deductible to \$2,500 and waiving/deferring the deductible at this time for the Seay Property located at 410 N Iowa Street (old dipper lot-parking lot below the Chamber). The amount of the deductible for the site is \$2,500 and will be recorded on the property as a lien, effectively a deferral of the deductible to be paid back in the future. They will now proceed with the testing to see if there is contamination, once the completed paperwork is received. If there is contamination, the site will be cleaned up with grant funds.

- B. Fire Department
 - 1. Fire Department Quarterly Report

Fire Chief Brian Whitehouse presented his Fire Department report. The 2% fire insurance dues came in over budget. The total number of calls is down from January-August. Part of the fire protection contracts were posted in 2015. They recently went through an insurance audit and the ISO rating remains the same at 3. A training tower would affect this rating and the Department sees this as a future need. Whitehouse reported they have a need to purchase tires and some gear equipment for maintenance updates. They are also looking to replace some of the concrete apron at the station. The Department currently has 33 members. A couple of the officers attended a recruitment meeting which was beneficial. The support truck will eventually need to be replaced. They are planning for their Open House on Saturday, October 15th.

3. Sewer Rate Change Ordinance

Ben, from Town and Country Engineering presented the proposed rate change to the Council. They are proposing to leave the fixed rate at \$16.98 and increasing the volume rate to \$6.75 per thousand. They are also recommending to increase the annual Sewer Replacement Fund contribution from \$68,000 to \$97,000. They are also recommending using \$700,000 from the Sewer Replacement Fund and move to the cash account, but not adjusting the loan amount. The average user will see an increase from approximately \$33,00 per month to \$38.50, calculating to about \$5.50 per month increase in rates. The last major increase was done in the late 90's. The reason for the increase is due to the \$4.1 million sewer plant upgrade (replacing 90% of the equipment at the plant). The sewer rate increase must be in place in order to close the loan in mid-November. The grant amount has increased to approximately \$634,000. Some pay requests will be paid prior to the loan closing, but can be reimbursed with the loan funds once the loan monies are received. Motion by Ald.
