  - 1. Ambulance Quarterly Report

Chief Brian Cushman provided a 2016 report for January - May. The current call number is down 75 calls from the same time last year. Open House was held on May 21st, with the event hosted at Harris Park with approximately 240 people showing up for the event. They were trying to promote community support by holding the event at Harris Park versus the ambulance garage. Dodgeville High School students helped with the event to work for community hours needed for the clubs they are involved with. They also assisted in handing out over 100 bicycle helmets to kids and adults. He stated with recent State approval to allow First Responders (EMR-Emergency Medical Responders) to count as a legal crew for
