Discussion and Possible Action on Kent Johnson Special Assessment Letter

Attorney Vernon Jesse with Murphy Desmond Law Firm was present representing Kent Johnson. Kent owns property north of County Rd YZ which will likely never to be developed due to the sleep terrain. Mr Jesse reviewed some meeting minutes from 2000 and 2001 regarding deferred special assessment discussions between the City staff and the residents. At the time separate resolutions were adopted with some properties paying when they hook up to service and some when they hook up OR sell their property. The Memorandum of Deferred Assessment for Mr Johnson's property states that he would have to pay when hooked up or when he conveyed the property. He was under the understanding based on the public hearings that he would never have to pay if he never hooked up.

Attorney Brownlee reviewed the resolutions and memorandums that were recorded at the Register of Deeds which do state that Mr Johnson was aware of the regulations. The deferred assessment for Mr Johnson is approximately \$100K.

Attorney Jesse asked the Council to review the minutes from 2001 and asked the Council make a motion regarding Mr Johnson's situation. The Council chose to take no action and referred Mr Johnson and Attorney Jesse to continue to discussing with Brownlee.

3. Discussion and Possible Action on Resolution 2021-1041: Conditional Use Permit for Parcel 216-1302, currently zoned B-H, to allow mini storage units to be built on the property and to also allow outside storage.

Council members asked about what "outside storage" meant and were concerned that junk could sit outside. They thought the Design Review could address outside storage. Lee pointed out that conditional use permits will now be recorded and stay with the property. The Council chose to put no conditions on the permit.

Motion by Tremelling, second by DeVoss to approve resolution 2021-1041 for a conditional use permit issued to John Meyers for storage units located between County YZ and Brown St.

4. Discussion and Possible Action on Resolution 2021-1042: Certified Survey Map located in the NW ¼ of the SE ¼, NE ¼ of the SE ¼ and the SW ¼ of the SE ¼, Section 22, T6N, R3E, City of Dodgeville, Iowa County, Wisconsin. (Property lying south of the Greater Heights Subdivision)

The Council discussed the proposed CSM. This CSM adjusts the CSM approved at the previous Council meeting by 93'. This will allow for a larger outlot. The Plan Commission has recommended approval.

Motion by DeVoss, second by Meuer to approve resolution 2021-1042 for a Certifed Survey Map to replat Lot 1 and Outlot 1 of CSM 1888. Roll call vote. Motion carried 6-0.

Approval of the "Stage 2" ward plan is needed so the County can continue with Stage 3 approving the Supervisory Districts.

Aulik explained that due to the pandemic, the Census figures were released several months late, and therefore the timeline to get everything approved before the 2022 election cycle is very short. The ordinance being introduced would adopt the approved ward plan and the proposed county supervisory districts. It would also reestablish the aldermanic districts to align with the new ward boundaries. The ordinance will come back for possible approval at the November 2nd meeting.

Motion by Meuer, second by Mainwaring to introduce Ordinance 2021-1405: Ward Boundaries and Aldermanic Districts. Roll call vote. Motion carried 6-0.
