# 5. New Business

 Resolution 2021-1044: Initial Resolution Authorizing \$1,925,000 General Obligation Bonds for Community Development Projects in Tax Incremental Districts

Dave Ferris was present from Ehlers to discuss the bond sale. The sale will be for \$1.925M. The bonds will be for 20 years with principal starting in 2024 and the term includes the first couple years of interest only payments until cash flows into the TID. The City will need to get a new bond rating - the last rating is 10 years old. The City wants the best interest rate possible which they can get with a good bond rating driving competition.

The City will have to approve a "parameter sale" allowing the Mayor or Council President to accept the bids so long as the bid meets certain parameters. This method is being

used due to Council dates not aligning with sale dates. The closing date for the bond sales will be December 16, 2021.

There will be a second borrowing amount of \$780K for the developer incentive since that amount will be taxable. There are some options to work with a local bank and banker's bank to get a 20 year bond issuance. Ferris was looking for direction from the Council to pursue this option, which they gave informally.

The Armory had a 50 year lease with the City for the Armory Building that expired on August 31, 2021. The six acre property is now vacant. The Federal Government plans to renew the lease because they are required to do an environmental assessment. The assessment can take up to five years but will most likely be less.

Attorney Brownlee has some concerns about the language and would like the resolution passed contingent upon her approval of the lease document. PW Director Lee would like to ensure the building continues to be heated at the City's expense to avoid damage during the assessment process. He is speaking to an armory representative about this. Lee has also toured the property and stated that it seems to be in good condition.
