1. Discussion regarding Potential ATV Routes in the City

Several citizens and members of the Pointer Prawlers ATV group spoke regarding opening City streets. Ashley S. was the primary spokesman for the group. The Town of

Dodgeville recently opened all their roads for ATV use, and they would like the City to consider to open routes within the City. The Mayor asked various questions regarding certain route considerations. Ashley suggested modeling the ordinance after Iowa County's ordinance for consistency across the County. Dodgeville is the only community in Iowa County that does not allow for ATV's within the city limits, and residents currently leave the City to ATV elsewhere.

Scott Halverson, Dean Rogers, Jerry Lawfler, Al Christianson, Kristy Kelly and Travis K made several suggestions in favor of allowing ATV's within the City limits. Suggestions included noise and speed limit considerations, ideas provided from other communities that allow ATV's, acknowledging improved family time, and consideration of the economic benefit gained from bringing people to town.

PD Chief Bauer spoke about the history of complaints over the last few years regarding ATV's/UTV's. Bauer stated that if the City is going to open up, they should open the whole City besides just a street at time, which is expensive. Bauer suggested a possible referendum to gage citizen interest.

The Mayor and Council Members will plan to have a special session of the Common Council and the ATV group to work together on a proposal.
