 - A. Mayor/Council President & Clerk

Aulik stated that absentee ballots are slowly coming back for the Partisan Primary Election. This is the election that you can only vote for one party. Aulik and Wolfe will both be attending training all of next week as part of the Clerks/Treasurer's Institute.

The Mayor wanted to remind everyone that due a software glitch, utility bills only included base fees, so people are encouraged to pay based on their regular amount. The software issue has been resolved.

Reynolds-Lair provided an update that the Historic Preservation Commission, Historical Society and Dodgeville Library Annex will be at the non-profit event at the Town Square to talk about local history. The event is July 14th from 1-3 pm.

- B. Fire Department
 - 1. Dodgeville Fire Department Update

Brian Whitehouse provided an update on the Fire Department. DFD's next big ticket item is refurbishing Engine 5. Refurbishing it would run \$250K vs closer to \$400-500K for a new one. DFD has approximately \$300K already set aside in funding to pay for it.
