3. Farmers Savings Bank Interest Payment

Clerk Lisa Riley informed the Committee that an interest payment was received from Farmer's Savings Bank in the amount of \$16,488.98 (General Pooled Account - \$13,125.64 and Tax Account - \$3,363.34). It had been agreed upon for Farmer's Savings Bank to pay interest at .25% above the current LGIP interest rate. The LGIP interest market fluctuated monthly, after being stagnant for a few years. Joe Witmer realized the bank's system did not accurately calculate the interest and brought the matter to the City's attention, agreeing to pay the City for the correct interest amount for the entire year of 2016 and through March of 2017.

4. Annual Interest Comparison

Finance Specialist Nick Selchert prepared a spreadsheet showing interest income comparison for 2013, 2014, 2015, and 2016 for the Committee/Council to show the change since investing funds. From 2015 to 2016, the City went from receiving \$30,115.98 in interest in 2015 to \$73,637.49 in 2016. Discussion regarding the potential possibility of investing additional dollars.
