1. Review/Recommend Ambulance Rates for 2017

The Committee reviewed the current and proposed ambulance rates with EMS Chief Brian Cushman. Ambulance rates have not changed since 2012. 2. Special Assessment Deferral Request for Tom Ley Property

Tony Ley appeared before the Committee to request deferral of the Tom Ley Deferred Special Assessments, approximately \$128,000 which is currently outstanding. Some of the assessments date back to 1990. Tony is in charge of Tom Ley's estate and is requesting that the City defer the deferred special assessments on the Tom Ley properties. He requested that the deferred special assessments continue to be deferred after closing Tom Ley's estate. Tony Ley stated his opinion is that they are not getting any benefit from the infrastructure. Attorney Eileen Brownlee explained the process of special assessments to the Committee and Mr. Ley. Brownlee explained that the property owner has an opportunity to dispute the assessment at the time each one of the
