II. New Business

1. Review/Update Emergency Plan

The Committee reviewed the Emergency Response Plan template used and recommended by Iowa County Emergency Government. Discussion followed regarding what direction to proceed - review and update the old plan or move forward with the County plan outline. The current plan needs to be updated to be submitted with an ambulance report in June. Also discussed the need to review emergency plans with the schools, as currently the emergency response personnel are not aware of the existing plan. Current and potential Emergency Operations Center (EOC) locations were discussed. The EOC will need a generator, multiple phone lines, and wireless internet access. Potential locations with generators are Fire Station, Ambulance Garage, Police Department, Iowa County Courthouse, Iowa County Highway Department, and Lands' End. The best facility location as an EOC is the Iowa County Courthouse. Discussed the possibility of including installation of a generator at City Hall, with the library addition. City Personnel will need to review their department section within the template and complete the information needed. All information should be submitted to David Bauer. The goal will be for City Personnel to review/update information and meet together, as needed, over the next few months, bring back to the Committee in March, and then to Council for approval.
